	Committee decided to use KFON as the primary connection and
	earmark fund in the Budget Estimate. Also decided to send proposal
	to Government for retaining the existing BSNL connection, in the
	initial stage, mentioning the specific requirements of KSREC.
	Representative from Finance Department observed that the Budget
	Estimate includes all project proposals submitted for funding, even
	without obtaining the approval. Committee entrusted Director to
	examine the budget estimate and make it more realistic.

	Committee agreed that KSREC is taking earnest efforts to raise the revenue by encashing the technical capability and hence requires certain clearances from Government for the time bound completion of projects. Committee entrusted Director to address Government incorporating all issues. Chairperson directed Finance Department to examine the matter and issue appropriate orders.  Committee approved the Budget estimate with the following modifications  a) to delete the amount of Rs. 4606 lakhs forecasted under item No. 39 in the receipt side.  b) to include the sanctioned budget provision and actual amount received in the income side along with the projection for the next year to have a clear comparison of figures.
